# Terms of Purchase of IEEJ Technical Report No.1386 "Recommended practice for simulation models for automatic generation control" and Separate CD-ROM

These terms of purchase (the "Terms") provide for the terms and conditions of purchase of Technical Report No. 1386 "Recommended practice for simulation models for automatic generation control" (hereinafter the "Technical Report") and the separate CD-ROM (hereinafter the "CD-ROM") sold by the Institute of Electrical Engineers of Japan (hereinafter the "IEEJ"). By carrying out the procedure for purchase of the Technical Report and the CD-ROM, a purchaser of the Technical Report and the CD-ROM (hereinafter a "Purchaser") shall be deemed to have consented to the Terms in force as of the time of the order.

#### Article 1 (Copyright)

- The copyright of the Technical Report, the electronic data in the CD-ROM (hereinafter "Electronic Data"), and the electronic data that may be downloaded from the IEEJ's website (hereinafter "Download Data") shall be vested in the IEEJ.
- 2. It is prohibited to reproduce, reprint, duplicate or distribute the Technical Report, Electronic Data and Download Data without permission. It is also prohibited to upload Electronic Data and Download Data to the Internet, including distributing them on any website belonging to an individual or organization, or on any social network service (SNS).
- 3. Electronic Data may be subject to revision (including by way of Download Data) without notice to Purchasers. When Electronic Data are revised, the data that include revision only of the part in question may be provided in such a way that they may be downloaded from the IEEJ's website, etc.
- 4. A Purchaser who publishes or discloses any simulation or other contents using the Technical Report and Electronic Data in an academic paper, on the Internet, or in any other way shall clearly indicate the Technical Report and Electronic Data as the source. In particular, when Electronic Data are indicated as the source, the

following statement must be presented:

IEEJ Investigating R&D Committee on recommended practice for simulation models for automatic generation control: Recommended practice for simulation models for automatic generation control CD-ROM, mm yyyy, Ver.xx

The year/month and the version set forth on the CD-ROM shall be inserted at the "mm yyyy" and "xx" part above. When Download Data are used due to revision of Electronic Data, the registration date of the Download Data shall be also included as the source.

### Article 2 (Arrangement of Equipment)

The Purchaser shall arrange by themself any equipment, software and other materials necessary for using the CD-ROM and making a simulation on an analysis example with the use of Electronic Data.

## Article 3 (Approval and Rescission of Purchase)

The IEEJ may not approve the purchase if an individual or organization wishing to purchase the products hereunder falls under any of the following items:

- If it turns out that the person has ever violated the Terms;
- If it turns out that there is any false entry or any serious error or omission in the purchase order; or
- 3. If the IEEJ otherwise finds that purchase is inappropriate.

## Article 4 (Commercial Use)

If a Purchaser uses all or part of the Technical Report, the CD-ROM and Electronic Data primarily for a commercial purpose, the Purchaser shall obtain authorization by paying a usage fee separately designated by the IEEJ; provided, however, that usage authorization may be denied if the IEEJ finds that the purpose is inappropriate.

#### Article 5 (Damages)

If a Purchaser engages in any act in violation of the Terms or any wrongful or illegal act, and thereby causes any damage to the IEEJ, the IEEJ may claim damages it incurs against the Purchaser.

#### Article 6 (Exemptions)

- The IEEJ shall not provide any guarantee whatsoever with respect to the Technical Report, Electronic Data or Download Data, including in terms of their contents or functioning. The IEEJ shall not provide any support with regard to the Technical Report, Electronic Data or Download Data.
- 2. The IEEJ shall under no circumstances be responsible for any damage, dispute or other issue caused by the Technical Report, Electronic Data or Download Data for whatever reason. Additionally, the IEEJ shall under no circumstances be responsible for any failure or damage arising during use of the CD-ROM.

#### Article 7 (Revisions of Terms)

When the IEEJ finds it necessary, the IEEJ may revise the Terms. In this case, the IEEJ shall give notice of the revision of the Terms, contents of the revised Terms and the effective date by publishing them on the IEEJ's website or by any other means that the IEEJ finds appropriate.

## Article 8 (Governing Law)

The formation, effect, performance and construction of the Terms shall be governed by the laws of Japan.

# Article 9 (Competent Court)

Any dispute arising out of or in connection with the Terms shall be brought in the Tokyo District Court as the agreed exclusive jurisdiction of the first instance.

#### Article 10 (Miscellaneous)

When handling any personal information of a Purchaser related to the purchase of the Technical Report and the CD-ROM, the IEEJ shall follow the provisions of "IEEJ Privacy Policy (Basic Policy for Protection of Personal Information)." Any matters not stipulated herein shall be determined through

bilateral consultation between the Purchaser and the IEEJ.
